

## **International Chair in Bioethics - ICB**

### **Statute Amnon Carmi World Prize in Bioethics**

#### **1. Purpose of the Award**

1.1. The basic idea beyond awarding the prestigious **Amnon Carmi World Prize in Bioethics** is to reward individuals and/or groups for efforts in promoting bioethics education worldwide; Encourage citizens all over the world to promote, contribute to, and strengthen the values of Bioethics teaching and Human Rights and honor Prof. Amnon Carmi's vision and life-long engagement in favor of bioethics education.

#### **2. Planes of Activity**

2.1. The following is a list of planes of activity regarding the prize. It is emphasized that this is not a closed list:

2.1.1. A scientific achievement in the field of bioethics teaching.

2.1.2. Social/public achievement to promote bioethics teaching.

2.1.3. Interdisciplinary research in bioethics teaching.

2.1.4. Development of curricula and syllabi in bioethics teaching.

2.2. The ICB may, from time to time, determine concrete issues and/or subjects in bioethics on which it seeks focus concerning the prize awarding.

#### **3. Eligibility for the Prize**

3.1. the prize is open to nominees from **all over the world** who meet the following conditions: Researchers, Lecturers, Professionals and/or Organizations with proven contributions in the field of bioethics.

3.2. Affiliation with the ICB is not a prerequisite for submitting applications for the prize.

#### 4. Application Procedures

- 4.1. Application for the prize will be submitted in English using an **application Form** which can be found on the ICB website.
- 4.2. Technical instructions and rules for submitting candidacy can be found on the ICB website.
- 4.3. The prize will be awarded once a year or once in about a year and a half, depending on the intervals between the ICB's World Conference in Bioethics, Medical Ethics & Health Law.
- 4.4. Time and deadlines for submitting nominations will be announced for each award on the ICB website.

#### 5. Prize Committee

- 5.1. The Prize Committee will be nominated by the ICB and be composed of notable experts from among ICB members and/or outside the ICB. The composition of the committee members may change from time to time.
- 5.2. The head of the ICB will be the president of the prize committee, but will not vote on the committee's decisions.
- 5.3. The committee will discuss the nominations submitted and select the winner according to criteria of **Excellence, Public Contribution and Future Impact**.
- 5.4. The Prize Committee may, at its sole discretion, disqualify candidates and/or their work submitted to the Prize Committee.
- 5.5. The Committee will publish its decision concerning the winner at least 90 days before the prize delivery ceremony date.
- 5.6. The Committee's decisions are final and cannot be appealed.

#### 6. The Prize

- 6.1. The prize will include a Certificate of Appreciation from the ICB as well as a monetary prize to be defined.
- 6.2. Payment of applicable tax concerning the prize, if applicable, in accordance with the laws of the country in which the winner resides, will be deducted from the prize awarded to the winner.

6.3. The prize will be awarded at an official and festive ceremony to be held as part of the ICB's World Conferences in Bioethics, Medical Ethics & Health Law.

6.4. The winner's name and work will be published on the ICB website.

7. **Validity of the Terms and Conditions of this Statute**

7.1. The validity of the Statute shall apply as long as it is not revoked by the ICB.

7.2. The ICB reserves the right at all times to amend and/or cancel the Prize and/or this Statute.
